### PROCUREMENT OF FIREWALL FOR PPSBI HEAD OFFICE

THIS AGREEMENT, made this \_\_\_ day of \_\_\_\_\_ between **Philippine Postal Savings Bank, Inc.**, a thrift banking institution, duly organized and existing under the laws of the Republic of the Philippines, with principal office at Postbank Center, Liwasang Bonifacio, 1000 Manila (hereinafter called “the Entity”) of the one part and **KEYSTONE SOLUTIONS, INC.**, a corporation, duly organized and existing under the laws of the Republic of the Philippines, with principal office at unit 1707 Hanstone Square, 17 San Miguel Avenue, Ortigas Center, Pasig City (hereinafter called the “Provider”) of the other part:

WHEREAS, the Entity is desirous that the Service Provider will provide a **Firewall Device and Services - Main Branch (Head Office)** (hereinafter called “the Services”) and the Entity has accepted the Bid for **One Million One Hundred Seventy-Six Thousand Pesos Only (₱1,176,000.00)** by the Service Provider by providing and completing such Services and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) the Bid Form and the Price Schedule submitted by the Bidder;
  - (b) the Entity’s Notification of Award;
  - (c) the Technical Specifications (Terms of Reference);
  - (d) the Performance Security; and
  - (e) the Invitation to Bid.
3. In consideration of the payments to be made by the Entity to the Provider as hereinafter mentioned, the Provider hereby covenants with the Entity to provide the services and to remedy defects therein in conformity with the provisions of this Contract in all aspects.


4. The Entity hereby covenants to pay the Provider in consideration of the provision of the services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.

IN WITNESS whereof, the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


