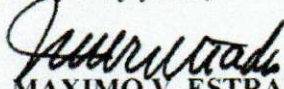

Contract Agreement

PROCUREMENT OF ARMORED CAR SERVICES FOR LOT 4 SOUTH LUZON AREA

20 JUN 2017

THIS AGREEMENT, made this ____ day of _____ between **Philippine Postal Savings Bank, Inc. (PPSBI)**, a thrift banking institution, duly organized and existing under the laws of the Republic of the Philippines, with principal office at Postbank Center, Liwasang Bonifacio, 1000 Manila (hereinafter called "the Entity") of the one part and Armortech International Transporter Corporation, a corporation, duly organized and existing under the laws of the Republic of the Philippines, with principal office at 3rd Floor, CTK Annex Bldg. II, #70 Nicanor Roxas St. corner Banawe, Quezon City (hereinafter called the "Service Provider") of the other part:

WHEREAS, the Entity is desirous that the Service Provider will provide **the armored car services** (hereinafter called "the Services") and the Entity has accepted the proposal for **One Million Three Hundred Fifty Two Thousand Four Hundred Pesos Only (₱1,352,400.00)** by the Service Provider by providing and completing such Services and the remedying of any defects therein.

WHEREAS, the Entity shall evaluate the job performance rendered of the Service Provider every mid point of the contract duration with the Bank.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) the Bid Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications (Terms of Reference);
 - (d) the General Conditions of the Contract;
 - (e) the Special Conditions of the Contract;
 - (f) the Entity's Notification of Award;
 - (g) the Performance Security;
 - (h) the Invitation to Bid; and
 - (i) the Bid Bulletins.



3. In consideration of the payments to be made by the Entity to the Provider as hereinafter mentioned, the Provider hereby covenants with the Entity to provide the services and to remedy defects therein in conformity with the provisions of this Contract in all aspects.
4. The Entity hereby covenants to pay the Provider in consideration of the provision of the services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.

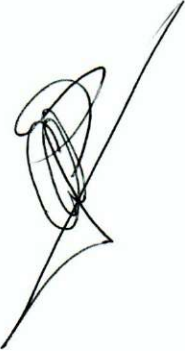
